# Manager's Report by Rob Clarkson



The Lake remains at full pool and our water quality is excellent. The busiest Holiday for our lake is quickly approaching. We have many new boaters this season and not all of us have read and understand the rules of the water. No Wake areas are 75' from the shorelines and marked with small round white buoys. This means that you do not make a wake inside this area ever. At the mouths of no wake coves are also buoys which are cylindrical and bear orange markings. These buoys indicate the entire cove is no wake. "A wake is defined as the movement of water created by a boat underway great enough to disturb a boat at rest, but under no circumstances shall a boat underway exceed five (5) miles per hour while in a NO WAKE area. 625 ILCS 45/5-12

We have had many new PWC's that have come onto the water with the less restrictions put on these watercrafts. This is going to make boating on a small lake such as ours even more of a challenge. Cutting in and out of traffic is never allowed. Following the counterclockwise direction of traffic must be always adhered to.

As we all head out to watch the fireworks on the lake lets be sure we have gone thru all the lighting on our watercraft. Navigation and anchor light are required after sunset by state law. Docking lights are only permitted to be used when docking not when traveling on the waterway. These bright lights make it difficult or even impossible to see the navigation lights of your vessel and create a dangerous environment for all when used incorrectly. The only legal lighting for your boats exterior is red/green on bow and white on stern. Those colorful under lights are illegal and IDNR will cite you for using them.

Boating safety is everyone's responsibility. Know the rules of Holiday Lake as well as the state laws regarding safe operation of your watercraft.

Help us save maintenance costs by not driving into the out lots when the ground is wet and by putting your trash in the receptacles. Please be respectful and give room on the roadways while the maintenance crew repair our roads and culverts.

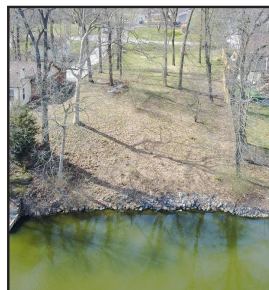

**Manager's Report**

**Matt Ressler** I have a question on that Rob. **Matt Ressler** We wrote four citations in the last 30 days, basically. **Rob Clarkson** No, it says four incidents reported. **Matt Ressler** How many citations were written. So they wrote eight citations in the last month. Is there anything you guys can do different? I mean, it's not working out, I don't think it is. **Rob Clarkson** You're writing a citation, you're fining them. Is it letters or citations that you're seeing on that? **Matt Ressler** Says letter. **Rob Clarkson** There's a letter, not a citation. Citations are if they don't comply within 30 days. **Matt Ressler** But if you start our fines process they get 30 days regardless, so now you're giving them 60 days to become compliant. Correct. **Rob Clarkson** No you're giving them 30, you're sending them a letter and tell them in 30 days, if it's not done you're getting the citation. They do a follow up on that follow up date and if it's not completed then or they haven't communicated with us, then they get their citation. **Matt Ressler** But they only found this many, letter wise, 3 in 30 days. You can drive down this road from here to St. James Road and there's 15, because I counted them coming in tonight. Derelict vehicles, unkept properties, boats sitting in the woods. **Rob Clarkson** There's a separate one for suspected derelict vehicles. A lot of those letters went out. **Matt Ressler** I'm just not seeing the community getting cleaned up. And I've been saying this for the last couple of years. I just don't think our public safety guys are doing their jobs. Look at the data that we got from the office, it clearly tells you, we wrote \$800 in citations last year, or whatever it was, compared to five years ago. Do you have an answer for that? **Rob Clarkson** Well, you don't have the same people out here you had five years ago, either. And some of them are on a special list that we can't talk about up here. **Matt Ressler** If you can't talk about them up here, but the other ones that we can talk about? If you pay attention driving from here to St. James Road and look, how many times a day do they drive past. **Rob Clarkson** I drive it four times a day, and I haven't seen 15 of them? **Matt Ressler** How many have you seen? **Rob Clarkson** The ones that I've addressed. **Matt Ressler** So they are getting addressed? **Rob Clarkson** I feel they are, yes. **Matt Ressler** I see you guys really attacking this grass thing already. You know, you got to attack all our covenants, rules and bylaws equally across the board. Because if you don't, you're setting yourselves up for a lawsuit. You understand what I'm saying? **Rob Clarkson** Oh yeah, I hear you.

### Old Business

#### **Fish Stocking**

**Anthony Harrell** We will be getting the hybrid stripers, those are available. We are replacing the pure stripers which aren't available with the hybrids. And we'll be getting the flatheads when they are caught. **Rob Clarkson** The fish shocking will be done next Wednesday. **Matt Ressler** They've also shocked in the past a lot later, haven't they? **Rob Clarkson** It's always been May.

### New Business

#### **Correspondence**

**Anthony Harrell** We have a letter from a member regarding lake lowering, I will read it into the record. "Holiday Shores Lake Lowering Proposal. I would like to voice the suggestion to consider dropping the lake level every year, and not every 5 years. Many lakes drop their lake level annually, and I'd like to suggest we consider the same. Benefits of dropping the lake level: The principal benefit of lake draw-down is that it exposes the root system of invasive aquatic plants that grow in shallow water by drying them out and freezing them. (Source: Dr. George Knoecklein, limnologist and principal, Northeast Aquatic Research, Notre Dame University article- [https://www3.nd.edu/~aseriann/Lake\\_Drawdown2.pdf](https://www3.nd.edu/~aseriann/Lake_Drawdown2.pdf)) Nitrate runoff from residential yard and farm fertilizer is a large contributor to lake pollution. Nitrogen feeds algae blooms that use up a lot of the dissolved oxygen in the water, thus choking fish life. Dropping the lake in the fall flushes a lot of this contamination out, then allows the lake to fill naturally over the late winter and early spring when rainfall is high and herbicide/pesticide use for the year is still low. We've had elevated e-coli levels at times requiring our beaches to be closed, due to the excessive number of geese and other waterfowl. Lowering the level every fall would help to flush a lot of this out. It allows for the checking of fish structures under docks that are otherwise not visible. This past winter I was able to pick up lots of trash that washed in around my dock ... beer cans, bottles, large logs, and other hidden hazards I can only see when the lake is low. Lake residents can do a trash cleanup around their docks when the water level is down. Lastly, it allows anyone who needs it the opportunity to make annual improvements or repairs to their dock or seawall, not just every 5 years. My suggestion is that we maintain dropping the lake every 5 years on September 20 as the rule currently stands, as this allows for a prolonged period of dock maintenance and shoreline repair. But I'd like to suggest additionally that in every year that doesn't end in a -0 or -5 we consider dropping the lake annually, exactly one month later (October 20) and allow it to naturally refill at the same date as it stands now. That strikes a balance of prolonging the boating season for fall boaters, yet allows for the benefits of the points as highlighted above." Brent Furrow (885) **Tony Harris** I think it'd be something to get feedback from the membership on what they'd like to do. The benefits sound interesting but whether we would actually get those or not I don't know. **Anthony Harrell** So there are several things in here. We don't have any weeds in the lake. You ask anybody in the bass club or who fishes out here. That's one of the complaints from people who fish is we don't have any weeds. So that's kind of a moot point. The other thing is the geese. Generally that's a summertime issue when we've had the e-coli. I don't see how lowering the lake is going to help that in the mid-summer. **Matt Ressler** The only thing that I really see that it benefits is the algae bloom. Because a lot of your other lakes right now have already experienced a big algae bloom and we don't have that because we just lowered our lake. **John Crotty** We've gotten lucky the last couple of years of dropping down that it filled up quickly. You do that every year we could limit our use of our lake. Because we've had years it doesn't come back up.

#### **Open Floor**

**Matt Ressler** The marina has a waiting list for people to store their boats up there. If we looked at our outlots and possibly put more posts in, so people will know that they're there for them to use. Is there a possibility Rob, that we could put some more posts in on our outlets for mooring? **Rob Clarkson** There are places we could put them. We added some to Spanish Cove when we did the silt

removal where it wasn't accessible before because it was only 18 inches of water, now it's eight foot. **Matt Ressler** What would be an additional cost for some posts? There's a lot of people that are having to take their boats in and out whenever they could just take them to an outlet and tie them up. **Rob Clarkson** With the post and labor probably, \$17 post. **Matt Ressler** So if look at all of our outlets what would it cost? **Tony Harris** You'd probably have to look and see how many you could put on there before you give an answer for that one. **Rob Clarkson** We usually put them 12 foot apart so we would have to get a running footage of each outlot. **Anthony Harrell** Not every outlot has anything on it right? **Rob Clarkson** No, there's very few that have posts on them. **Brian Wood** We would have to look at each one and see if they are even accessible by boat. **John Crotty** I agree. I think right now not everybody knows what outlots they can park on. **Matt Ressler** I'm all for it, I'm going to be buying a pontoon soon, so I'd like to have somewhere to tie it up and not have to be on a waiting list at the Marina. **Anthony Harrell** How big is that waiting list at the marina? **Matt Ressler** It's at least a year long. **Brian Wood** How many outlots do we currently have? **Rob Clarkson** I want to say there's probably at least seven around the lake. Some people don't know about. Some have docks on them that were approved years ago. Honestly, I thought some of those dock were people's personal docks for years. **Brian Wood** I think maybe in the future we should look at making it more pronounced with the mooring posts and that they are outlots and they are available for the membership to use. I don't know if the posts would reflect that, or you could put something in the manager's report. **Matt Ressler** Do we have like an extra \$500 sitting somewhere to where we can start so the members could start using these outlets? **Tony Harris** I think we could find \$500 in the budget. **Rob Clarkson** It would help reduce your problem on the ramp too, instead of having to put in and take out every time. **Brian Wood** So is that something we could do then for the next meeting to just get an estimate on how many we would need. **Rob Clarkson** Give me two meetings. I can do some measurements and see how



# BEACH AND SWIM SAFETY

## ***Holiday Shores Regulations***

1. Beaches located within the Association are restricted to members and guests only.
2. Glass bottles, fires, pets and food are prohibited from the beach area.
3. Persons under the age of 16 are allowed to swim: if being escorted by an individual 17 years of age or older or there is a lifeguard on duty.
4. During each shift, a lifeguard is allowed a ten-minute break every hour, during that time, swimmers under 17 years of age must exit the water, if not with an adult.
5. Holishor Association Inc. is not responsible for one's personal items, nor any personal injury sustained while using Association facilities. (water, beach, grounds, etc.)

## ***IL Dept. of Public Health Regulations***

1. Beach water is not intended, nor fit, for human consumption. Do not swallow beach water.
2. Beach admittance may be denied to individuals having:
  - Contagious diseases
  - Infections (foot infections, ear infections, vomiting, diarrhea, inflamed eyes, unhealed abrasions or lacerations, skin lesions, or bandages of any kind.
3. Persons under the influence of alcohol or behaving erratically will be denied access/removed from the beach.
4. No food, drink, gum or tobacco products are permitted in the swim area.
5. The use of glass containers is strictly prohibited.
6. Children who are not toilet trained must wear tight fitting plasticized/rubber swim pants.
7. Swimming alone is discouraged.
8. Diving in shallow water is prohibited.
9. Personal conduct that endangers the safety of ones' self, or other beach patrons, is strictly prohibited.
10. Swimming is permitted between sunrise and sunset, except during the times of thunder and/or lightning. Swimmers are required to exit the water during these conditions and remain out for a minimum of 30 minutes following the last detection of thunder or lightning.
11. Pets are prohibited from the beach area.
12. Beach patrons are not permitted to feed local wildlife or entice them to stay in the area. Wildlife harassment is also strictly prohibited.
13. Measures taken to protect ones' self from the sun, such as sunblock, beach umbrellas, etc. are strongly recommended.

# PERSONAL FLOTATION DEVICES

**PLEASE READ THE IMPORTANT INFORMATION BELOW REGARDING PERSONAL FLOTATION DEVICES. IT IS IMPERATIVE THAT THE APPROPRIATE PFD IS KEPT ON EACH WATER-CRAFT WHILE BOATING ON HOLIDAY LAKE AND SU TWAN LAKE. THIS INFORMATION CAN BE FOUND ON PAGES 9 AND 10 IN YOUR HOLIDAY SHORES BOATING RULES.**

Personal Flotation Devices from 625 ILCS 45/4 1 No person may operate a watercraft unless at least one U.S. Coast Guard approved PFD of the following types or their equivalent is on board for each person: Type I, Type II or Type III. No person may operate a personal watercraft or specialty prop craft unless each person aboard is wearing a Type I, Type II, Type III or Type V PFD approved by the United States Coast Guard. No person may operate a watercraft 16 feet or more in length, except a canoe or kayak, unless at least one Type IV U.S. Coast Guard approved PFD or its equivalent is on board in addition to the PFD's required in paragraph A of this Section. A U.S. Coast Guard approved Type V personal flotation device may be carried in lieu of the Type I, II, III or IV personal flotation device required in this Section, if the Type V personal flotation device is approved for the activity in which it is being used. When assisting a person on water skis, aquaplane or similar device, there must be one U.S. Coast Guard approved PFD on board the watercraft for each person being assisted or towed or worn by the person being assisted or towed. No person may operate a watercraft unless each device required by this Section is: Readily accessible; in serviceable condition; of the appropriate size for the person for whom it is intended; and legibly marked with the U.S. Coast Guard approval number. Approved personal flotation devices are defined as follows:

- Type I A Type I personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have more than 20 pounds of buoyancy.
- Type II A Type II personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type III A Type III personal flotation device is an approved device designed to keep a conscious person in a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type IV A Type IV personal flotation device is an approved device designed to be thrown to a person in the water and not worn. It is designed to have at least 16 1/2 pounds of buoyancy.
- Type V A Type V personal flotation device is an approved device for restricted use and is acceptable only when used in the activity for which it is approved.

No person may operate a watercraft under 26 feet in length unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway; however, this requirement shall not apply to persons who are below decks or in totally enclosed cabin spaces. The provisions of this subsection I shall not apply to a person operating a watercraft on private property.

Further, no person may operate a watercraft on Holiday or Su Twan lakes unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway.

**Shaun Diltz** We usually do it every even year but obviously, it was canceled last year, because of covid. They do it at the same time each year in the same areas. Initial reports are our bass look a little bit higher than what they were in 2018, which is still about where we should be by a little bit. The only thing that really stuck out was in 2018 and 2016 and 2014 we shocked one yellow bass all together. This year, it's going to be in the hundreds. There's lots of yellow bass. So in 2012, 2010, and 2008, we were at 150, 450 and 150 yellow bass. So there was a big influx and now they're coming back. The fishermen have seen them crappie fishing and stuff. I'm shocked actually, it put it in a different perspective on how many they were. **Rob Clarkson** There were some good red ears. **Shaun Diltz** Other than that everything looked good and healthy. So from a fishermen's perspective, there wasn't as many green Sunfish as I thought there would be, they're kind of a nuisance out here too. But other than that, good size on the fish and numbers too. **Jerry Allen** What about the number of crappie? **Shaun Diltz** So they never shock crappie real good. They seem to miss the spawn by a week or two. They shocked about the same number, which is in the teens, nothing crazy. But he usually goes with the fishermen's report on how many there are as far as if you can just sit there on a dock and catch 100 crappie then you're overpopulated. **Rob Clarkson** He looks at the length and the size of their eyes. That tells you that they're stunted. **Shaun Diltz** Yes, the ones we did get were stunted. But they were a little bit bigger than what they were five years ago. **Tony Harris** We were talking about stocking the lake with the hybrids instead of the pure stripers because we couldn't get them. Where do we stand on that? **Rob Clarkson** I talked to the Herman Brothers and they're going to be delivering some hybrids. We will not be getting pure stripers this year. **Shaun Diltz** So just in the future, I think it's a good opportunity to get the purebreds in the lake if we can find them. They live four times longer; they get four times bigger. They'll eat a lot more shad in the lake. **Rob Clarkson** We just need to work on it earlier in the year.

**New Business**

**John Crotty** Since the last meeting, we had a leak start on the Su Twan dam. It looked pretty severe, to a point that we had to have an emergency meeting of the board to review it and determine the next actions. We did begin to lower the lake at Su Twan Friday morning and the good news is we lowered eight inches and the leak stopped. So it wasn't as severe as it appeared. We did go ahead and lower it 16 inches to give us some time to look at some bids and determine how we're going to repair it. Rob, do you have any further updates for us before we look at the bids that you provided us? **Rob Clarkson** We reached out to Stutz Excavating initially, they do quite a bit of dam work. They came out looked at it and this was when it first started seeping and they weren't very concerned. Within two weeks, it got to the point where I had no idea whether it was going to last overnight, and we had Stutz back out. He was very concerned at that point. There was water visibly,

Also, be safe this July 4th - leave the fireworks to the professionals. Thank you to everyone who joined us on our community yard sale day. We had a great turnout and enjoyed seeing everyone who stopped by and supported our department. We practiced our fire and water skills in June as well. We held our water rescue drill and then did our live house burn. On July 4th we will help out at the ski show and with the fireworks display. We responded to 16 calls over the past month. Anyone wishing to join our department is always welcome. You don't need previous experience to join. Stop by any Monday evening to learn about us. ### Medic Minute - Summer Safety (Annual Review)

Summertime is when everybody enjoys themselves outdoors. Here are some tips to keep yourself safe.

**Sunburn** - To prevent sunburn, avoid being in the sun between 10 a.m. and 3 p.m. Use a sunscreen with a SPF of at least 15 or higher (preferably 30 or higher), that offers both UVA and UVB protection, and has the active ingredient PABA (unless you are allergic to it). Apply 15-30 minutes before exposure and re-apply every two hours, even if it's waterproof. Note: a minimal amount of sunshine on the skin is needed to produce Vitamin D, which along with calcium are needed to strengthen bones and prevent osteoporosis.

**Heat Exhaustion/Heat Stroke** - Heat exhaustion occurs when your body can't sweat enough to cool you off, with symptoms of fatigue, weakness, dizziness, nausea/vomiting and skin that's cool, clammy, pale or flushed. Make sure you wear lightweight and light-colored clothing, and take frequent breaks if working outdoors. Treatment includes drinking lots of cool water, getting out of the sun to a cool spot, and sponging your body with cool water. Heat exhaustion can sometimes lead to **heat stroke**, which happens when your body stops sweating but your core temperature continues to rise, often to 105 degrees or higher. This requires emergency treatment. Symptoms are confusion, delirium or unconsciousness, and skin that's hot, dry,

reddened or flushed - even under the armpits. Call 911 immediately.

**Bug Safety** - Summer is the time for mosquitos. To help prevent exposure: use insect repellent with DEET, wear long sleeves and pants, close windows, empty any areas of free-standing water, and use EPA approved indoor and outdoor insect sprays or foggers. Ticks can carry disease - the most widely known is Lyme disease, which is rising dramatically due to climate change. Ticks become infected after feeding off hosts with the bacteria, such as deer, mice and squirrels, and then transmitting it to humans. Symptoms include: a "bull's-eye" rash, fever, nausea/vomiting, palpitations, or joint pain and swelling. No test presently exists to identify tick bites or the type of tick. For removal of a tick: wear gloves, use forceps or tweezers to grab the tick at skin level without crushing it, gently pull until free - don't twist or turn, it may leave a piece in the skin. You can also put liquid soap onto a cotton ball and cover it for about 15-20 minutes, which may cause it to release itself. Place the tick into a sealable jar or plastic bag and take it to your doctor if you de-

velop symptoms, who will then prescribe treatment with an antibiotic.

**Poisonous Plants** - Poison Ivy grows as a vine or shrub in the grass or on trees; Poison Oak grows only as a shrub, usually in the western U.S.; Poison Sumac is a tall shrub or small tree found in wooded areas of the eastern states. The rashes are caused by their oils and aren't contagious. Once the skin has been washed and clothing removed, it can't spread. Once exposed, you have about 10 minutes to wash away the oil or a rash may develop within 12 hours. You can use a topical hydrocortisone cream and an oral antihistamine for itching. If the eyes or a large area of rash is involved, contact your doctor.

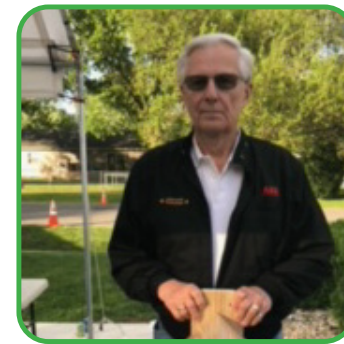

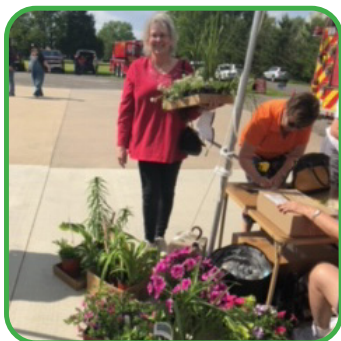

# **BOATING SAFETY**

**Legal Compliance** – “All watercraft operated on Holishor Association Lakes must adhere to and comply with state and federal laws as stated in the Illinois Registration and Safety Act.”

**Speed Limit** – “The maximum speed of any watercraft operated on Holiday Lake shall be 55mph or as defined in the Reckless or Careless Operation section of the Holiday Shores Boating Rules. Operation of said watercraft shall be in a manner that does not create an exaggerated wake. Intentionally ‘plowing’ or ‘pushing water’ at speeds greater than no-wake, but less than those typically maintained while ‘on plane’ is not permitted.”

**Watercraft/Registration** – “All watercraft being operated on Holiday and Su Twan Lakes must have a current state registration decal and numbers, **one/current Holiday Shores decal**, and lot numbers affixed.”

**Operating Age** – The minimum age to operate watercraft on Holiday Lake is 12, providing the individual has passed a state certified boater safety class. Individuals between the ages of 12 and 18 must possess a valid boater safety card to operate watercraft, unless under the direct supervision of a member or a person over the age of 18, who has member consent.

**Watercraft Limit** – No member shall have more than three motorized watercraft registered to the same membership in operation at one time.

**Size Limit** – All watercraft being operated on Holiday Lake except pontoon boats with tubular bottoms, are limited to 22 feet in length. Pontoons are restricted to 28 feet.

**Traffic Pattern** – All watercraft being operated on Holiday Lake must follow a counterclockwise direction of travel, similar to that of operating a motor vehicle on the roadway.

**Boating Hours** – Boating on Holiday and Su Twan Lakes is permitted 24 hours a day, but watercraft are restricted to No-Wake speeds from sunset to sunrise.

**Noise Level Limit** – No watercraft may be operated on Holiday or Su Twan Lakes in a manner that exceeds a noise level of 75 decibels. This restriction includes inboard/outboard motors, stereos, etc.

**Restricted Areas** – No watercraft shall be operated in any manner except prescribed for areas marked No-Wake, Swimming Area, etc. Holiday Lake is considered No-Wake when the lake reaches 9” above full pool and 16” below full pool.

**Reckless or Careless Operation** – **Careless:** No watercraft shall be operated in a manner that puts any person or property in danger or at a rate of speed that prohibits the driver from stopping the craft within a safe distance. **Reckless:** No watercraft shall be operated in a manner that willfully and wantonly puts life, limb, or property of another person in danger. This restriction applies to actions such as weaving through traffic, jumping wake when visibility is obstructed, following too close to skiers, playing ‘chicken’, or passing another craft in a manner that produces a hazardous wake/wash. This restriction also applies to the misuse of water skis, wake boards, or other devices.

**Water Skiing** – Water skiers, wake boarders, tubers, etc. may not be towed without at least two competent persons in the tow boat, to observe the individual(s) being towed and provide assistance if distressed/injured.

**Distance** – Operators must keep a safe and reasonable distance between their craft and other lake users, such as swimmers, downed skiers, fishermen, etc. They must also maintain a distance of 75ft from shore when making a wake. Seventy-five-foot markers have been replaced with new, larger white/blue buoys.

**Orange Flag** – Operators are required to display a bright orange flag on their vessel **any time they have a skier, tuber, wake boarder, etc. in the water.** The flag must be a 12 inch by 12 inch square and affixed to the highest point of the craft, such as a ski tower or pontoon top.

**Racing** – Racing of any watercraft on Holiday or Su Twan Lakes is prohibited.

**Power Turns** – Power Turns (also referred to as 180s or 360s) are permitted as long as the following criteria are met: 1.) Craft is not unreasonably close to another craft, causing it to swerve or take evasive action to avoid a collision. 2.) Not done in a manner that causes the driver and/or passengers to be thrown from the craft. 3.) Not done in a cove or in a manner which causes a nuisance to another member.

**Engine Cut-Off** – All watercraft (prop-driven and PWC’s) equipped with an engine cut-off device may not be operated unless the device is properly functioning and it’s lanyard is securely attached to the driver.

like you turned a faucet on, running out of the dam, It had channeled down the side of the dam. That's when we decided we're going start pumping to alleviate any kind of pressure. We're very relieved that six hours into it when we were down eight inches and it quit leaking. We kind of took a step back at that point and obviously it wasn't nearly as important that we address it that day. They were ready to start on Monday. We had our meetings, determined we would reach out to more contractors. One showed up, one had no interest in bidding it under the presumption that it was going to be an emergency and they didn't want any kind of liability. As it turns out, it's not an emergency, they still don't want to come back. We'll put that in a note in their file and not call him back out for any other work. Kamadulski and Stutz have both bid the job. They both looked at it and agreed at the way it needs to be approached. Originally it was to completely rekey the dam. Both of them said that 50 feet would do it, 25 feet on each side of where they believe the leak is coming from and they're talking about an impervious wall. What they're going to do is excavate down a couple of feet below the obvious leak. So where they hit dry soil, they'll go a couple more feet and mix it with bentonite and basically make a big wall, put it in lifts and do compaction. They said it's the way the Corps of Engineers repairs seepage and stuff in the levees on the river, and the way they've fixed many other ponds and whatnot, so it seems to be a pretty good method. They have their bids here tonight and both are ready to start whenever we're ready to. **John Crotty** We won't have to lower the lake at this point. **Rob Clarkson** No, as long as it doesn't get lower when they're digging they're fine. Neither one was worried. There'll be quite a bit of soil between the lake and where they actually dig. **Shaun Diltz** Is this not the exact same thing we did two years ago. **Rob Clarkson** No. Two years ago, we took a pipe out. **Shaun Diltz** I thought we had a soil compaction. **Rob Clarkson** We did, we had a soil compaction, but we did lengthwise on it, not width on the dam. He doesn't think its leaking where we took it out at all, he thinks it's going around it. **Shaun Diltz** If it's going around the bentonite like it did before, if we do this key that we did like six foot, will it go around this bentonite wall again. **Rob Clarkson** That's why they're going 50 feet, where we did a four-foot-wide trench they're going 50 feet long and perpendicular. **Shaun Diltz** Water does weird things. I guess my issue is liability or warranty on any of this. If it springs a leak around that bentonite wall is something that we're going to have to look at again. I don't know if this is an issue that I have to worry about, it's just if the water is going to hit to the bentonite, could it find a way around it? And then is that something we're going to have to pay to fix again? **Ty Van Ryswyk** I would say their answer to that is going to be, from a contractor that deals with stuff on the ground, they don't know what's in that dam. We know what's in that dam probably shouldn't have been there. They're not going to take responsibility for that, they're going to do everything they can to fix this problem. And if it finds a way around it, we're going to have to fix that later on. **Rob Clarkson** I think the initial bid that we got for the emergency would have answered that question on whether they're going to be liable for it or not, right? Because they were going to remove the lake. **John Crotty** We've got two bids. Kamadulski Excavating. Their bid for the work that's been described is \$30,592.38. Stutz excavating proposal comes in at \$17,600. Neither one includes the pumping that we've currently had to do already, or any further we would have to do. I think Rob you said the only thing is Stutz is going to dig fresh clay from our own property. Kamadulski is going to use the existing and mix it back in. Stutz would actually have to do a little more digging. From what I can see they're both equivalent. **Jerry Allen** Makes a motion to accept the proposed offer from Stutz Excavating for the repair of the Su Twan dam. **Shaun Diltz** Seconds **All in favor** **Motion carries** Discussion ensued about different ways to help cover the cost of the dam repair.

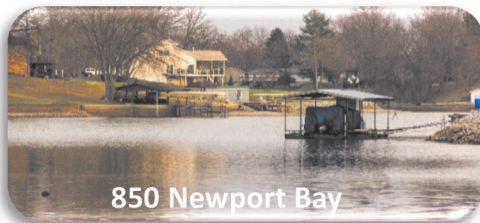
